Controller's privacy statement - website and cookies

If you visit a website <https://cybergame.sk-cert.sk> that writes cookies, a small file called a cookie will be created on your computer.

A cookie is a short text file that a website stores on your computer or mobile device (including tablet) browser when you browse it. If you visit the same site next time, the cookie will help you connect faster. In addition, the website will "get to know" you and offer you the information you prefer, ensure that an advertisement you have already seen is not repeated, or allow you to enter or offer you to complete the information you have filled in on previous visits to the website and, following this information, display relevant content and offers of estimated activities and services that we assume you could use.

Cookies may be used to analyse traffic to our website through services such as Google Analytics. These are analytics tools that help website and app owners understand how their visitors use their website. Cookies can be used to provide statistics about website usage without personally identifying individual visitors.

If you set your browser to block the writing of cookies, it is possible that some parts of our websites may not function without some problems or slowdowns.

What cookies do we use?

Essential cookies

These cookies enable the use of basic functions and are necessary for the operation of our website. We may use them to authenticate users, to prevent fraud and unauthorised access to user accounts on our services or to offer different functionalities. **As these cookies are necessary for the operation of our website, we must use these cookies and your consent is not required to use them.**

Functional cookies

These cookies help perform certain functions such as sharing website content on social media platforms, collecting feedback and other third-party features. **We need your consent to use these cookies and therefore unless you provide your consent, the website will not use these cookies.**

Statistical cookies

Performance cookies are used to understand and analyse key performance indices of a website, which helps in providing a better user experience to visitors. **We need your consent to use these cookies and therefore unless you provide your consent, the website will not use these cookies.**

Advertising cookies

Advertising cookies are used to deliver relevant advertisements and marketing campaigns to visitors. These cookies track visitors on the website and collect information to deliver tailored advertisements. **We need your consent to use these cookies and therefore unless you provide your consent, the website will not use these cookies.**

The following **analytical tools** are used:

Legal basis for processing

If we are able to identify the person of the website visitor when recording, this will constitute processing of personal data. We must have a legal basis for such processing.

In the case of necessary cookies, this will be the legal basis of the legitimate interests of the controller according to Article 6(1)(f) GDPR, who has an interest in ensuring that the operator's website is operated. At the same time, such access is also permitted by Article 109(8) of Act No 452/2021 Coll. on Electronic Communications, which states that: 'Anyone who stores or accesses information stored on a user's terminal equipment shall be entitled to do so only if the user concerned has given demonstrable consent. This shall not prevent the technical storage of or access to data whose sole purpose is to transmit or facilitate the transmission of a message over a network, or where it is strictly necessary for an information society service provider to provide an information society service expressly requested by the user.'

In the case of other cookies, the legal basis for consent to the processing of personal data pursuant to Article 6(1)(a) GDPR is obtained from you as the data subject.

Automated decision-making and profiling

If we have your consent to process your personal data for marketing purposes, we link this to information about your activities on the website. The linking occurs by accessing our website. You can **object** to such processing at any time or, if the automated decision affects your rights and freedoms, request an individual decision on our part. The method of withdrawing consent is described below.

Withdrawal of consent if we process your data on the basis of your consent

If we process your data on the basis of your consent, this consent can be withdrawn at any time by:
